WHEREAS, the Board of Trustees is in receipt of a confidential memorandum from Special Counsel Peter Linden from the law firm of Kirby McInerney, LLP to the Trustees dated May 20, 2016 (the "Confidential Memorandum"), and

WHEREAS, the Confidential Memorandum advises the Board regarding pursuit of legal claims of the Retirement System involving a securities investment made by the Retirement System and regarding taking a leadership role as a plaintiff pursuing those legal claims, and

WHEREAS, the Board has been advised by the Executive Director and General Counsel in this matter in closed session, and

LA QUINTA HOLDINGS, INC. SECURITIES LITIGATION - CONTINUED

WHEREAS, the Board has considered this matter in open session, therefore be it
