A meeting of the Investment Committee of the General Retirement System of the City of Detroit was held on **Monday, May 06, 2019**, at the Retirement System's office at Ally Detroit Center, 500 Woodward Avenue, Suite 3000, Detroit, Michigan. The Committee discussed the allocation of up to \$30 million dollars to a Fund of Fund manager that will allocate a portfolio of "diverse (MWBE) private equity managers. The Committee members gauged the feasibility and decided to bring this recommendation back to a future meeting for approval.

General Retirement System Investment Committee Special Reporting Obligations: Interim Confirmation of Pension Certificate Executive Summary and Recommendation

Motion #19-40-05: Thomas Sheehan moved to acknowledge receipt of the draft Interim Confirmation of Pension Certificate and authorize that said certificate be signed by the Committee Chairperson. Kenneth Whipple supported. The motion passed unanimously.

Fiduciary Liability Coverage

The Committee discussed the renewal of the various coverages under the Fiduciary Liability Policies. The Committee discussed the appropriate level of liability coverage. The Chief Investment Officer and General Counsel were requested to research the level of coverage carried by other comparable systems and report back to the Investment Committee. Motion #19-40-06: June Nickleberry moved to revise the Fiduciary Liability coverages as discussed; taking away the last layer of \$10 million in coverage and reviewing this matter further after a report from staff. Thomas Sheehan supported. The motion passed unanimously.

Motion #19-40-07: Thomas Sheehan moved to approve the recommendation of the Chief Investment Officer and Investment Staff and start the liquidation process for a full redemption from the UBS Trumbull Property Fund. Kenneth Whipple supported. The motion passed unanimously.

Motion #19-40-08: David Sowerby moved to proceed with the recommendation of the Chief Investment Officer and Investment Staff with respect to the Raven Asset Based Opportunity Fund IV to allow the allocation subject to the firm raising \$250,000.00 for Fund IV per the amended recommendation of the General Retirement System Board. Kenneth Whipple supported. The motion passed unanimously.

Motion #19-40-09: Thomas Sheehan moved to proceed with the recommendation of the Chief Investment Officer with respect to updating the CEM Investment Benchmarking study at a time that is administratively feasible. Kenneth Whipple supported. The motion passed unanimously.
